# **Specifications** for

### One New 3/4 Ton Pickup Truck 4WD

**Intent:** It is the intent to describe a New 2022 model <sup>3</sup>/<sub>4</sub> ton pickup truck, with a 6.2 V8 gas engine. This vehicle will be of the manufacturer's latest design and a model in current production. These specifications are for illustration purposes only; variations will be considered.

Bidder will specify make and model of the truck he proposed to furnish, and must submit with his bid the manufacturer's latest published specifications sheet and advertising literature that is available describing the unit bid.

This will be a three-part bid:

A: New 2022 pickup as described

B: Trade allowance of a 2017 pickup with similar specs and approximately 54,000 miles. This vehicle may be seen by appointment at the DPW garage. Please call 518-962-4877.

C: Net price of New 2022 with trade.

The unit bid shall meet these specifications without modification to the standard production model except for the addition of optional equipment specified.

All bids will be equal to or better than specified.

Unit will be delivered complete with all equipment, tools, accessories, and controls regularly supplied by the manufacturer as standard equipment on the unit bid, whether specifically mentioned in these specifications or not, except for those items otherwise specified herein. All items listed as standard equipment on the manufacturer's latest published specification sheets are assumed to be included in the bidder's proposal.

Bids must be submitted to the Town Clerk in a sealed envelope marked "Truck Bid" no later than 2:30 on October 26, 2021. Bids will be opened during the Regular Town Board Meeting at 3:00 p.m. that same day. The Town of Westport reserves the right to accept or reject any and all bids.

Bidder will list on a separate sheet, attached to his proposal sheet, any and all variations from, or exceptions to, these specifications as compared to the unit he proposes to furnish.

#### **Specifications are as follows:**

CHASSIS: <sup>3</sup>/<sub>4</sub> ton Class, 4-wheel drive with Regular Cab, 8- foot aluminum flatbed with cab protector, and 142" wheel base.

**CAB:** Regular Cab, with super capacity fresh air heater and defroster. Trailer type heated mirrors over standard quality with power glass.

**CAB INTERIOR:** Cloth 40-20-40 seat. Light color cab interior preferred. Intermittent wipers. AM-FM Radio. Cab to be equipped with air conditioning, cruise control, blue tooth capable, and power windows.

**BODY EXTERIOR:** Silver in color.

**ENGINE:** 6.2 liter V8 or equivalent gas engine.

**TRANSMISSION:** Electronic 6 speed with tow/haul mode with cooler.

**AXLES:** Locking rear axle.

**AXLE RATIO:** 3.73 gear ratio.

**GVWR:** 10,000 LBS.

**TIRES:** All terrain type with a minimum size of LT245-T5R17.

**ELECTRICAL:** 240-amp alternator, 12-volt system, dual electric horns, front side marker light and all other lights and reflectors to meet state and federal regulations.

**BRAKES:** Power

**STEERING:** Power

**BUMPER:** Front and rear painted with trailer package.

**ACCESSORIES:** Trailer Package complete with integrated trailer brake controller, wiring and hitch minimum class 4. Front tow hooks. Two entry cab steps. Outside temperature readout. 8'6" stainless straight blade plow with joystick controller.

Vehicle must be NYS inspected at time of delivery.

#### NON-COLLUSION STATEMENT
