We also need eight tires for the truck. I am trying to get a price but haven't been able to connect with the tire salesmen. The Wadhams well had a collapse. We have been working to get the other well pump repaired. There is emergency funding available, if we qualify, since we are in a state of emergency with the current wells. There has been a boil water in Wadhams. We are hoping to have this fixed by tomorrow.

**SUPERVISORS COMMENTS:** We have had a request to hire lifeguards for the beach at Ballard Park. I have spoken to Deb Pastore about the condition of the beach. They are going to get the beach cleaned up and add sand. It will be a viable beach. The Board has decided to hire lifeguards for the summer of 2021. Councilperson Brankman asked about the street light project. Supervisor Tyler has not heard from National Grid but will be calling them tomorrow. The Westport Chamber of Commerce is organizing fireworks for the 4<sup>th</sup> of July. There is no permit required for fireworks, however, they need to notify the fire department. The 4<sup>th</sup> of July parade will be Saturday, July 3<sup>rd</sup> at 4:30 pm. Councilperson Morrison announced the Hometown Hero's banners will be hung this upcoming weekend. The Town is in receipt of communications from Charter.
