PUBLIC COMMENT: David Whitford from HAPEC (Housing Assistance Program of Essex County) is present to update the Board on the progress of the Housing Grant. They started qualifying homeowners late last year and will continue until they have qualified/disqualified all the applicants. Councilman Kirkby asked what disqualifies a person. Mr. Whitford explained usually over income, we also had a person that the home was not their primary residence. Councilman Kirkby asked is there an appeal process? Mr. Whitford said no because typically they are over income. The project range from \$30,000 to \$70,000 and we are using other grants to supplement the projects. The grant that was received by the town is a \$25,000 max per project. There will need to be two more public hearings.

Patrick Dougan is present to request the Board give him a small strip of land/ right of way next to his property that he has been maintaining for 49 years. Supervisor Tyler asked Mr. Dougan to put his request in writing.

YOUTH COMMISSION: There was an issue with a counselor that is being addressed.

COUNCILMAN VIENS asked about the Primary Election on August 23, 2022. Supervisor Tyler said we have not received any information about the primary yet but when we do we will need to change the date of our next meeting.
