DPW SUPERINTENDENT'S REPORT: The CHIPS money will have a substantial increase from last year. The crew is continuing to sweep and grade. They are making a new driveway to get the new well rig into Wadhams. SUPERVISOR TYLER, "we are hoping that the test well works or we are facing a serious problem". The Lee Park Beach is flooded. The water has not gotten into the beach house. The beach was well used last year. We would like to continue to maintain the beach this year. The Town Board agreed. There is a possible water leak near the Catholic Church, this may be runoff. We used the listening equipment and we can hear the pebbles moving in the water. It's a really good piece of equipment. We have been doing bank runs to Munson's gravel pit to prepare the road for Wadham's Water Improvement Project. It will take about 4-5 days to complete. Decker Road is next to be paved. We have been working with the County. The freeze and thaw during the winter, like we just had, creates problems for the roads.

SUPERVISOR TYLER: The Town Board is in receipt of a letter from the Westport Planning Board addressed to the County.

COUNCILPERSON MORRISON would like to wish all the mother's a very Happy Mother's Day.

SUPERVISOR TYLER asked if there is any other comment from the public.

PUBLIC COMMENT: Colin Powers is present to inform the Town Board about BRASS (Boquet River Association, Inc.). They had a good first meeting. They had a presenter from Fish and Wildlife about Salmon restoration. They discussed the successes, challenges, and set goals for the year. They encouraged the board to please let the group know if they see projects along the river. Currently they have 12 board member. They sent out a mailer to 350 residents. They had between 30-40 members renew from the mailer and some renewed with lifetime membership.
