Mr. Hainer: I had emailed the board information from Rolling Hills Farm about their project. They are working in an agriculture district which is protected by the Department of Agriculture and Markets.

A lengthy discussion followed about the change of use for a building included in their special permit. The building will be used in the process of making wine. Board members had questions about septic and water use, traffic in the area, effects on the community, public use and wine storage. Many board members are encouraged by the growth and development of Rolling Hills Farm. A board member asked if a site visit will be necessary.

Mr. Hainer: Please email your questions to me by December 2, 2020 so we can have an organized list for Rolling Hills Farm.

Chairwoman Severance: Do we have anything else?

Ms. Fairbanks: So we got the APA permit from the Amish?

Mr. Hainer: Under the APA that property is one lot so the APA took jurisdiction.

Ms. Fairbanks: They built a house there.

Mr. Hainer: If they didn't subdivide they could build another farmhouse right there.

Mr. Hainer: I had asked the APA about a perc test but I haven't heard back from them yet.

Mr. Maron: Should the planning board draft a letter to help get the answers? I can draft a letter about the septic to get the questions answered.

Mr. Hainer: Under the APA when a property is being used for agriculture in an agriculture district all single family dwellings and mobile homes occupied by farmers, employees and immediate families involved in the farm operation together comprise one principle building, they are not considered subdivision. Agriculture use structures are not considered a subdivision. Anyone can have an outhouse the DEC can have privies.

Chairwoman Severance: I think this is a topic that doesn't just apply to the Amish. Let's discuss the webinars.

Mr. Hainer: You each need to take a course every year as planning board members to fill the educational requirement.

Mr. White: It's not difficult. I was able to complete a course yesterday.
